Similarly, you will also intimate the name of the persons who are near relatives of the proprietor /Partners/Directors and working as Junior Engineers and / or Gazetted/ Commissioned Officers in the BRO /MoD. Please note that you will not be entitled to issue of tender in certain areas, where your near relative is working. Decision of the Registering Authority in this regard shall be final.


